Detective Grimm served as a police officer in the Middletown Township, N.J. Police Department for 37 years, prior to his retirement in 2008. Barry attained the rank of Detective First Class in the Major crimes Unit; in addition, he was a forensic identification specialist and fire/arson investigator for the Department. Detective Grimm provided technical, photographic and laboratory assistance in almost every significant investigation, including homicides, sudden deaths, burglaries, narcotics offenses and fire investigations.

Since 1985, Barry has been an Adjunct Instructor for The National Fire Academy in Emmitsburg, MD., teaching numerous courses offered in the Arson Curriculum, specifically Interview/Interrogation Courtroom Techniques, Tobacco, Firearms and Explosives (ATF) as a subject matter expert in the redevelopment of the former Fire/Arson course offered at the National Fire Academy, and has been one of the primary instructors since the initial offering in July 2007.
