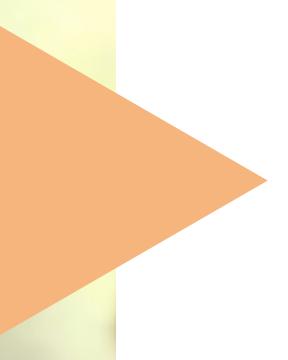

Homeowners Association Notes to the Financial Statements

The financial statements have been prepared in accordance with the new Generally Accepted Accounting Principles FASB 606 requirement. Monthly financial statements are prepared on a modified accrual accounting basis and fiscal year end financial statements are prepared on a full accrual accounting basis.

A change has been made to the Income Statement previously provided in the board packet in the past, the statement was prepared as a combined operating and reserve report. The statement is now provided as two separate reports, one for operating and one for reserves.

A new report has been added to your financial package. It is the Reserve Fund Transfer Report and is located right after the Reserve Fund Income Statement. The report shows reserve funds activity for the current fiscal year.

The allowance for doubtful accounts listed on the balance sheet is a bad debt accrual for the fiscal year end June 30, 2020. This balance will be adjusted at the June 30, 2021 fiscal year end.

The financial statements were prepared without the August Bank statement as it was not received in time for the preparation of the statements.

Business Licenses & Fees expense is payment to Butte County Department of public Health for the swimming pool and spa permits.

Clerical/Other Office Supplies expense is the result of copies for the month of July and association financial review mailings.

Postage expense is the result of postage for the month of July and association financial review mailings.

Landscape-Sprinkler expense is due to broken sprinkler repair.

Maintenance & Repair-Supplies expense consists of insect traps, trash receptacles and paint supplies purchased.

Pest Control expense is understated for the month as the vendor invoice was not received in time for the preparation of the financial statements.

Pool/Spa-Contract expense is understated for the month as the vendor invoice was not received in time for the preparation of the financial statements.
